FACT (Florida Assertive Community Treatment)	The Florida Assertive Community Treatment (FACT) teams utilize an evidence – based treatment approach to deliver comprehensive care and promote independent, integrated living for individuals with serious mental illness. FACT teams primarily provide services to participants where they live, work, or other preferred settings, and are available 24 hours a day, 7 days a week. The programmatic goals are to prevent recurrent hospitalization and incarceration, as well as to improve community involvement and overall quality of life for program participants. Care Coordination	Care Coordination is a time-limited service that assists individuals with behavioral health conditions who are not effectively engaged with case management or other behavioral health services and supports. Care Coordination is intended for individuals who demonstrate high utilization of acute care services, including crisis stabilization, inpatient, and inpatient detoxification services. However, Care Coordination is also intended to avert high utilization of such services. Therefore, Care Coordination can be uniquely tailored to serve a broad spectrum of individuals from both a system level and provider level. NAVIGATE (First Episode of Pysycosis)	The services provided in this program are community-based and mental health services (Program for First Episode Psychosis) and will focus on the 16-35 age range. The program comprehensive intervention program for people who have experienced a first episode of psychosis by helping people work toward personal goals and recovery using a team approach within the community-based system of care. Forensic	This population is defined as adults or juveniles adjudicated as adults who are charged with or at-risk of being charged with a felony offense pursuant to Chapter 916, F.S., and who are referred to the Network Service Provider subject to conditional release, pre-commitment diversion, or post-commitment diversion. This program does not pertain to individuals with only misdemeanor offenses. Individuals with non-violent felony offenses should be prioritized for conditional release and diversion. A non-violent offense is a crime that does not involve a violent crime against a person and is not one of the violent or capital offenses found in s. 916.145, F.S. MAT (Medication Assisted Treatment)	<p>Medication Assisted Treatment (MAT) is the use of medications, in combination with counseling and behavioral therapies, to provide a whole-patient approach to the treatment of substance use disorders. Research shows that when treating substance-use disorders, a combination of medication and behavioral therapies is most successful. Sheriff Outreach Programs	<p>Law enforcement interacts with individuals experiencing mental health and substance abuse crisis daily. LEO is frequently interacting with the same individuals for the same reason. This is primarily because individuals are not effectively connected with the services and supports needed to foster stability. NWF Health Network is contracting with sheriff offices in the NW Region to provide outreach and referral services, Gadsden, Wakulla, Jefferson, Liberty, Franklin and Taylor. MRT (Mobile Response Team)	<p>The Marjory Stoneman Douglas High School Public Safety Act, Ch. 2018-3, Laws of Florida, created a statewide network of MRTs. The goals of MRTs are to lessen trauma; conduct an independent assessment to determine if the individual may be safely diverted from emergency departments; prevent unnecessary psychiatric hospitalization; or divert from juvenile justice or criminal justice settings. MRTs are intended to provide on-demand crisis intervention services in any setting in which a behavioral health crisis occurs, including, but not limited to, homes, schools, the community, and emergency departments. Mobile response services must be available 24 hours a day, 7 days a week. Services are provided by a team of licensed professionals, master's level professionals, and paraprofessionals trained in crisis intervention skills. PATH providers perform community outreach to business owners, realtors, landlords, housing developers and other service providers to build strong relationships and identify new and existing opportunities to better assist individuals in accessing resources, employment, supportive services, and housing opportunities. Children may also have involvement with: the Department of Juvenile Justice (DJJ), the Agency for Persons with Disabilities (APD), recent Baker Acts, utilized various community resources, and/or in a child abuse investigation but not yet involved with dependency case management. PCIT (Parent Child Intervention Therapy)	Parent–child interaction therapy (PCIT) is widely used and evidence-based behavioral parent training approach for the treatment of emotional and disruptive behavior disorders in children aged 2 to 7 years. PCIT is a family-centered treatment approach proven effective for abused and at-risk children and their caregivers— birth parents, adoptive parents, or foster or kin caregivers. During PCIT, therapists coach parents while they interact with their children, teaching the caregivers strategies that will promote positive behaviors in children who have disruptive or externalizing behavior problems. Research has shown that, as a result of PCIT, parents learn more effective parenting techniques, the behavior problems of children decrease, and the quality of the parent-child relationship improves. Navigate Team	The program is designed to provide comprehensive and early intervention to individuals who have experienced a first episode of psychosis. When loved ones begin to have behavioral changes due to psychotic episode, it is often confusing. This is when everyone, including the individual and their family, need the most help and education to “navigate” the process and successfully find ways to achieve family well-being, our NAVIGATE team will be there to assist. The program work between ages 15-40 years old, have a diagnosis of schizophrenia, schizoaffective disorder, or schizophreniform disorder and have received antipsychotic medications for less than one year. Tess is available 24/7 via SMS.</p> <p>Developed in collaboration with mental health professionals, Tess provides self-help content that has been proven to lower symptoms of anxiety and depression in over 10 research studies. FCC (Family Crisis Care Coordination)	<p>Family Crisis Care Coordination serves children and young adults who are not effectively connected with the services and supports they need to transition successfully from higher levels of care to effective community-based care and/or to help further prevent additional out of home placements (psychiatric judicial, child welfare).
